Dr. Jan Hathcote, Chair of the General Education Subcommittee, presented the list of courses that will satisfy the new General Education Core Curriculum to the committee. The committee discussed the curriculum and voted to approve the list of courses. Some of the approved courses will also require approval of the Board of Regents Council on General Education. The subcommittee will continue to consider proposals to include courses in the General Education Core Curriculum.

While considering the proposals for a new institute and a new center the committee listened to the Provost's concerns abut the proliferation of centers and institutes at UGA and the need for a sunset clause to be added to the existing policy on centers and institutes. The committee discussed the policy and its provisions for periodic review of centers and institutes and agreed to revise it to include a sunset clause requirement.

The committee considered a request to reduce the capacity for the High Demand major in Social Studies Education (B.S.Ed.) by 50%. After much discussion, the request was denied.

The committee considered the request to terminate the majors in French and Spanish under the M.A.T. degree. After discussion the committee tabled the proposal until the next meeting.

The committee considered and approved the following Areas of Emphasis: Area of Emphasis in Birth through Five under the major in Special Education (B.S.Ed.) Area of Emphasis in Birth through Five under the major in Child and Family Development (B.S.F.C.S.) Area of Emphasis in Ibero-American Comparative Studies under the Major in Romance Languages (A.B.) Area of Emphasis in Marriage and Family Therapy under the Ph.D. in Child and Family Development
