Proposal to Deactivate the Minor in Psychology

Proposal for a major name change in Social Science Education under the B.S.Ed., M.Ed., Ed.S., Ed.D., Ph.D.

Proposal to offer the major in Consumer Economics (B.S.F.C.S.) as an External Degree at Griffin

The University Curriculum Committee approved, with regret, the deactivation of the minor in Psychology. The Committee understands the lack of resources facing the department and supports the department's priorities. Nevertheless, the deactivation of the minor is a clear loss to the liberal arts program at the University and diminishes the academic opportunities available to undergraduates. It is the strong recommendation of the UCC that resources be made available to Psychology at the earliest opportunity so that it may restore this important component of liberal arts education.

The committee approved a proposal for an Area of Emphasis in Residential Property Management under the major in Housing (B.S.F.C.S.)

The committee approved a new prefix: POPH – Population Health.

The committee discussed the revisions to the Bylaws regarding University Council Standing Committees proposed by the Statutes and Bylaws Committee. There was discussion on the consequences of the changes specifically the change of wording from "elect" to "select." The committee did not agree on whether this change would be beneficial for the functioning of the University Curriculum Committee.

The committee approved a request from the General Education Subcommittee to compile an inventory of University of Georgia courses that include General Education Abilities.

The committee received as an information item a draft of a proposed General Education curriculum. This draft will be considered by the University Curriculum Committee in the fall.

The committee re-elected Dr. William Vencill as chair for the 2006-2007 academic year.
