The committee approved a proposal for a new prefix: EPIT, Educational Psychology and Instructional Technology.

The committee approved a proposal to change the selection process for the high-demand major in Early Childhood Education (B.S.Ed.).

The committee approved the proposal to offer the following two Areas of Emphasis under the major in Health Promotion (B.S.H.P.):

Area of Emphasis in Health Promotion
Area of Emphasis in Health Services

The committee discussed the need for the intended majors designation. The committee agreed that the schools and colleges should be asked if there is any need to continue using the intended majors designation.

The plus/minus grading system was discussed. The committee agreed there was no need for further discussion until the pilot period is complete and the Board of Regents has granted permanent approval of the use of plus/minus grading on this campus.
