The committee approved a proposal for an increase in hours for English Education (B.S.Ed.). This proposal will be forwarded to the Board of Regents for administrative approval.

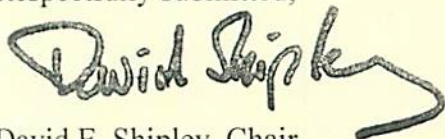
The committee approved a proposal to change the capacity numbers for the high-demand major in Social Studies Education (B.S.Ed.).
