The committee approved the proposal for a new prefix: ICON, Integrative Conservation

The committee heard a report from the Environmental Literacy Subcommittee concerning courses that satisfy the Environmental Literacy Requirement. The subcommittee reviewed the courses to determine if they meet either or both of the criteria in the current requirement. The UCC agreed to remove courses that do not meet either of the criteria effective spring 2011. The departments will be notified and have an opportunity to revise and resubmit courses for consideration prior to the effective date. The Environmental Literacy Subcommittee will meet during the summer and present a proposal to the Full University Curriculum Committee for consideration in the fall.
