## JUSTIFICATION:

Please see enclosed letter describing three related changes. As described in greater detail in that letter, the justification for the requested major name change is twofold: the new name is better descriptive of the content of the major, and the new name allows an area of emphasis that will allow undergraduate students to pursue ESOL teacher certification in the state of Georgia.

Dear Dean Spangler:
Please accept the enclosed materials as requests from this department for three related changes in our bachelor's-degree offerings. All three changes are part of our attempts to improve and expand our offerings in the academic area known generally as Teaching English to (or "for") Speakers of Other Languages (using the general abbreviation "TESOL"). The same topic is referred to by the Georgia Professional Standards Commission as teaching English to Speakers of Other Languages (using the abbreviation "ESOL").

1. We request to change the name of one of our department's BSEd programs from its current name of World Language Education to its proposed name of TESOL and World Language Education. The new name will better represent the current content of the major, which does currently include coursework in TESOL and also in world language education. It will also allow the development of the first area of emphasis requested below, a change that will allow undergraduate students to earn Georgia teaching certification to teach English to Speakers of Other Languages (ESOL).
2. The degree currently has four approved areas of emphasis, for students preparing for careers teaching Spanish, French, German, or Latin. We are requesting the establishment of two additional areas of emphasis, Teaching English to Speakers of Other Languages (TESOL) and Educational Studies in Language Education.
2.a. We request the establishment and approval of Teaching English to Speakers of Other Languages (TESOL) as a new (fifth) Area of Emphasis under the newly renamed BSEd in TESOL and World Language Education. Again, this formally recognized area of emphasis will allow undergraduate students to earn initial Georgia teaching certification in ESOL. Some of the course requirements for this area of emphasis do overlap with the requirements for students not selecting this area of emphasis, but this area of emphasis has a distinct focus on teaching English to speakers of other languages and was designed to meet Georgia Professional Standards Commission requirements for ESOL certification in particular. This new area of
emphasis is important to the health and growth of our TESOL program because it will allow students who are interested in teaching in Georgia schools to seek initial certification in ESOL at the bachelor's level.
2.b. Finally, we request the establishment and approval of Educational Studies in Language Education as a new (sixth) Area of Emphasis in the newly re-named BSEd in TESOL and World Language Education. The "Educational Studies" areas of emphasis are non-certification bachelor's degrees; that is, the new Educational Studies in Language Education area of emphasis (under the BSEd in TESOL and World Language Education) will allow students to complete this major even if they are not interested in completing certification requirements to be able to teach in Georgia public schools. This option is important to the health and growth of our TESOL program because there are many good career paths for TESOL educators or researchers in the United States and elsewhere that do not involve teaching in the public schools. There are also many other reasons why UGA students might choose to complete a double major or a Double-Dawg combination that provides them expertise in teaching English, or in working with people who are learning English, in a wide range of international professional settings.

In short, we propose (a) a change to a more inclusive and better descriptive name for one of our existing bachelor's degree programs and then (b) the development of two additional areas of emphasis under that degree, one intended to support students who seek initial Georgia teacher certification in ESOL at the bachelor's level and one intended to support students who seek expertise in TESOL for other reasons. We request that all three of these changes be effective as of the beginning of Fall semester 2019.

Students in this area of emphasis will instead complete additional coursework in the content and context of world language education or language learning.

Submission of a statement of purpose. This is a highdemand major. After meeting the entrance requirements, students will be selected based on the following highdemand selection criteria.
