Justification

The name Workforce Education is being requested to replace the name of the degree programs previously known as Occupational Studies to better reflect changes in the discipline. The program of Workforce Education promotes career and technical education and workforce preparation throughout the lifespan through programs in secondary schools, technical college, and business and industry. The requested changes in degree names and prefix will more accurately reflect the current emphasis of the majors in the Program of Workforce Education and places the program in line with similar program at other land grant institutions such as Penn State and University of Minnesota. At the time of the reorganization of the College of Education in 2004, one of the new Departments established was the Department of Workforce Education, Leadership, and Social Foundations. The programs previously offered in the Department of Occupational Studies (EOCS) became part of the new Department.
