RE: Proposal to change high-demand selection criteria for the Exercise and Sport Science major on the bulletin, effective Fall of 2012.

Currently the Entrance Requirements section of this major reads:

Overall GPA of 2.75. Completion of (<u>CHEM 1211</u>, <u>CHEM 1211L</u>) or (<u>CHEM 1311H</u>, <u>CHEM 1311L</u>), (<u>CHEM 1212</u>, <u>CHEM 1212L</u>) or (<u>CHEM 1312H</u>, <u>CHEM 1312L</u>), <u>CBIO 2200-2200L</u>, <u>CBIO 2210-2210L</u>, <u>KINS 2010</u>, <u>PHYS 1111-1111L</u> with a grade of "C" (2.0) or better. Students may apply for entrance to the major with these courses in progress. Submission of a statement of purpose. This is a high-demand major. After meeting the entrance requirements, students will be selected based on the following high-demand selection criteria.

We propose the following changes:

Overall GPA of 2.75. Completion of (CHEM 1211, CHEM 1211L) or (CHEM 1311H, CHEM 1311L), (CHEM 1212, CHEM 1212L) or (CHEM 1312H, CHEM 1312L), CBIO 2200-2200L, CBIO 2210-2210L, KINS 2010, PHYS 1111-1111L with a grade of "C" (2.0) or better. Students may apply for entrance to the major with 1-2 courses in progress for areas I-III, and only 1 course in progress for area VI. Submission of a statement of purpose. This is a high-demand major. After meeting the entrance requirements, students will be selected based on the following high-demand selection criteria.

The purpose of this change is to increase the criteria available for evaluating the student's ability to succeed in the major.
