Deactivation of the Birth Through Five Emphasis in the Child and Family

Development major

As the accompanying paperwork indicates, it has become necessary to deactivate the Birth Through Five Emphasis in the Child and Family Development major. All students who are currently pursuing this area of emphasis will be permitted to enroll in coursework to allow them timely completion of the emphasis. We have worked with the College of Education's Department of Elementary and Social Studies Education to ensure that their courses also will be available to these students. This decision has support of the CFD faculty as well as the College's Curriculum Committee. This decision has no adverse effect on faculty or staff since all teaching faculty will continue to support the general and/or the Child Life emphases.

PROPOSAL TO DEACTIVATE AN AREA OF EMPHASIS

School/College:	College of Family and Consumer Sciences

Major:	Child and Family Development – General Emphasis	
	(Currently there is a General Emphasis, a Child Life Emphasis and a Birth through Five Emphasis)	
Deactivation:	Birth through Age Five Emphasis	
	(Retain the major Child and Family Development – General Emphasis and Child Life Emphasis)	
Rationale:	This Birth through Five Emphasis is a joint program between the College of Education and the College of Family and Consumer Sciences. With the increase in undergraduate students in the Child and Family Department and the loss of faculty, the department no longer has the resources to continue this emphasis. Enrollment in the program has not been what was anticipated (15 current students; 3 cohorts of 5); therefore, the program is very expensive to run with the limited faculty resources.	
Deactivation Date:	Students are enrolled as a cohort. The current students will be allowed to continue in the program until they graduate. No additional cohorts will be added to the program. The next application date would be September 2012.
