On February 3, 2005, the Board of Regents approved a waiver of the 120 semester hour rule for some BSED majors in the College of Education including English education and foreign language education to require up to 129 hours. The faculty in the Department of Language and Literacy Education have voted to change the number of hours required for the English education and foreign language education majors from 120 to 129. This change in hours reflects a strengthening of intensive field-based experiences necessary to prepare high quality teachers. Upon approval I will submit the change in hours within the CAPA system.
