JUSTIFICATION FOR MAJOR/MINOR NAME CHANGE

The word science needs to be plural because this major involves multiple sciences and the current singular name does not reflect this fact. It is important that the name reflect the interdisciplinary scientific nature of this nutritional sciences major that provides students with the opportunity to take a diverse number of science-based courses. The changes to sciences also reflects the fact that multiple science courses that are required pre-requisites for admission to medical and other health-related professional schools and core components of this major. The change in the noun nutrition to the adjective nutritional is needed to make it clear that there is a nutritional focus to the major. The word nutritional reflects the fact that the plan of study is designed to include a core set of nutrition courses which is the primary emphasis of the sciences that will either be required and elective options.
