AGRICULTURAL AND APPLIED ECONOMICS MINOR

Students are required to complete at least 15 hours of course work (minimum grade of a "C" for each course) for the minor and all prerequisites must be taken prior to enrolling in the required courses. Courses taken to satisfy core Areas A through F may not be counted. Courses being counted as part of a student's requirements for a major shall not be counted as part of the course work for the minor. No student shall take more than one minor in the Department of Agricultural and Applied Economics.

I. Required Courses: (Minimum grade of C-) (7 hours)

AAEC 3400, Introduction to Agricultural Policy (3 hrs.) AAEC 3580-3580L, Intermediate Economic Principles (4 hrs.)

II. Select any three AAEC 3000- or 4000-level courses, except AAEC 3910, AAEC 4271, & AAEC 4990: (9-10 hrs.)

All prerequisites must be taken prior to enrolling in any courses.
