

Dear Dean Lauth,

I am writing to request that the name of the PhD degree offered by the Department of Public Administration and Policy be changed from "PhD in Public Administration" to "PhD in Public Administration and Policy." This matter was raised originally in a recent meeting of the department's Faculty Executive Committee. That Committee recommended the change and the matter was placed before our faculty for a vote where it was unanimously approved (15 yes, 0 no).

As you know, our PhD students prepare themselves in three substantive fields and in research methodology. The substantive fields include two that are mandatory (Public Administration and Public Policy Analysis) and one that is chosen by the student as an area of specialization. Because Public Policy Analysis is one of the mandatory fields that every student takes, and because focused study in public policy is an increasingly popular area of specialization for our doctoral students, the proposed change in the name of the degree will more accurately reflect the content of our program and the training of our students than does the current name.

Since its creation in 2002, following the establishment of the School of Public and International Affairs the previous year, the Department of Public Administration and Policy has significantly expanded course offerings in public policy analysis. The department now offers courses in: 1) the foundations of policy analysis; 2) policy analysis I and II; 3) the policy process; 4) policy implementation; and 5) policy evaluation. Additionally the department has developed several PhD-level seminars in specialized areas of public policy that are regularly offered.

The Department of Public Administration and Policy at the University of Georgia has long been recognized as one of the premier training grounds for scholars in the field of public administration. This change in degree name will recognize our substantial new strength in the field of public policy analysis and the core competencies of our current students. The proposed change does not involve any alterations to the curriculum or the commitment of any additional resources. The required "Name Change Justification Form" accompanies this letter.
