The Department of Educational Psychology and Instructional Technology is writing to request the development of a new course prefix for our departmental courses. Faculty members in the merged programs of Educational Psychology and Instructional Technology have been engaged in conversations regarding the efficiency of resources and the teaching of courses across programs in the department. Given the similarity of our curricular discourse, we believe that we may further the instructional arm of our department through explicit integration of our scholarship around common constructs.
