Change in MIS Selection Criteria

At its meeting on January 15, 2013, the Terry College Undergraduate Programs Committee unanimously (7-0) approved the addition of MIST 4610 and MIST 5750 to the selection criteria used for consideration when reviewing applications for the Management Information Systems (MIS) major. The current selection criteria and the proposed selection criteria are displayed below.

Dr. Maric Boudreau, MIS department head, requested this change on behalf of her department. MIS faculty members feel that considering student performance in the two additional courses will allow them to better assess applicants' interest and ability. Additionally, students who perform well in MIST courses but poorly in other selection criteria (particularly accounting) will have a better chance of admission to the major under the new criteria.
