8. Abstract of the Deactivated Program:

This Doctor of Philosophy program prepares graduates to construct knowledge that leads and advances the field of language and literacy education. Students may specialize in areas including Children's Literature & Language Arts, Secondary English Education, Foreign Language Education, Reading Education, and Teaching English to Speakers of Other Languages (TESOL).

The University established this degree for the purpose of providing properly qualified students with the opportunity to pursue research and other scholarly activities beyond the point that is possible in programs for the master's degree. This degree will be granted in recognition of proficiency in research, breadth and soundness of scholarship, and thorough acquaintance with a specific field of knowledge, not upon completion of any definite amount of work prescribed in advance. Evidence of such attainment must be provided through the presentation of an acceptable dissertation based upon independent research and the passing of such written and oral examinations as may be prescribed.

This program is being terminated because a new doctoral program in Language and Literacy Education has been approved. Students currently enrolled in the Language Education PhD will change their degree objective to Language and Literacy Education.
