Dear Curriculum Systems and Academic Affairs Administrators:

I am requesting on behalf of the faculty in the Department of Foods and Nutrition that the name of the department be changed to the Department of Nutritional Sciences. I am also requesting that the prefix be changed from FDNS to NUTR. The requested name change is necessary to unite the diverse areas of scholarship within the department and better communicate faculty expertise areas to those outside of academia as well as current and prospective students, other academic institutions, potential collaborators, and funding agencies. The Department of Foods and Nutrition consists of faculty members conducting a wide range of nutrition-related research, from cell and molecular studies, to clinical studies of metabolism, to community-based efforts to improve nutrition and population health. The proposed new name (Department of Nutritional Sciences) achieves these goals and is consistent with the names of similar departments at peer institutions as well as the administrative structure of the University of Georgia and the University System of Georgia. Furthermore, the new name more clearly differentiates the department from the Department of Food Science & Technology, a unit within the College of Agricultural and Environmental Sciences.

During this past year, faculty have carefully considered this decision and have engaged in meaningful discussions. Faculty response to Qualtrics survey confirmed a consensus that the name should be changed to either the Department of Nutritional Sciences or the Department of Nutrition. A special faculty meeting was held on Friday February 5th and a formal vote was taken for the name change as well as a separate vote for a new prefix.

Faculty votes for new name preference

- Department of Nutrition n=2

Faculty votes to change prefix from FDNS to NUTR

- Yes n=20
- No n=1

As the department head, I strongly support this request to approve changing our departmental name and prefix.
