# PROPOSAL TO ESTABLISH OR CHANGE THE ENTRANCE STATUS AND REQUIREMENTS OF AN UNDERGRADUATE MAJOR

**Date:** February 19, 2021

School/College: Franklin College of Arts and Sciences

Department/Division: Computer Science

Program (Major and Degree): Computer Science (B.S.)

**Proposed Effective Date:** Fall 2021

#### 1. Justification

What is the academic justification for instituting the requirement?

In Computer Science (B.S.), the courses build upon one another. If a student does not receive a "C" (2.0) or higher in an introductory class, they will not be successful in higher-level courses. Students are currently completing introductory courses without the necessary level of mastery. They then continue into courses they are not ready for and end up confused and frustrated.

To use the language of the Academic Affairs Policy Statement No. 9, Establishing or Changing the Entrance Requirements or High-Demand Status of an Undergraduate Major, special skills or abilities are required to complete major courses. In this case, students need to have basic to intermediate programming skills before attempting upper-level courses.

## 2. Requirements

What specific entrance requirements are proposed?

To be admitted into the major, students must have completed the following courses with a grade of "C" (2.0) or higher: CSCI 1301-1301L, CSCI 1302, CSCI 1730, CSCI 2610, CSCI 2670, CSCI 2720, and MATH 2250 (or their equivalents).

## 3. Results

How will the proposed requirement solve the academic problems outlined in the justification?

The requirement will ensure that students have received an acceptable grade in the introductory courses before moving on into the upper-level courses. This will ensure a smoother transition into upper-level courses. Overall, this will benefit students and faculty.

## 4. Consequences of the Requirement

# a. How will this requirement affect the major involved?

This entrance requirement will enable the Computer Science students to navigate through their subsequent courses with the necessary background that will enable them to succeed. With this requirement, based on the recommendation from the PRAC Review Committee and the fact that big companies such as Google and Microsoft have stopped recruiting our students due to the lack of their strong background, students will have the knowledge and the background that will enable them to compete with students from other institutions to work for such companies and be successful if they choose to continue their graduate education.

## b. What effects are anticipated on other majors within the University?

This change would not affect other majors.
