Justification:

The Undergraduate and Graduate Certificates in Museum Studies were approved by University Council in 2018 and have graduated close to 100 students. The certificates are housed within the Department of History in the Franklin College of Arts and Sciences. Students earning the certificate have gone on to careers in museums, libraries, and archives throughout the country. The certificates require completion of sixteen hours of course work, with three of the required courses using the FCID, Franklin College Interdisciplinary, prefix.

Students from all majors and colleges can apply to the certificate program. Identifying museum studies courses with their own prefix will enable students to find them more easily and understand the progression through the program. The faculty are currently preparing a proposal for an M.A. program and the new prefix would be used for future courses contributing to that degree program.

Once the MUSE prefix is approved, a course change will be submitted to change the prefix of the following courses:
