Program Abstract:

Provide a brief summary of the area of emphasis being proposed for termination.

The Master of Arts in Teaching (M.A.T.) in Middle Grades Education leads to initial certification for students who hold undergraduate degrees in other fields and who do not hold a teacher certification. The curriculum includes required courses and applied research individualized to the student's teaching interests in Language Arts, Mathematics, Science, or Social Studies, allowing students to gain advanced content knowledge and pedagogical skills in educating young adolescents.

The state approval body for teacher certification, the Georgia Professional Standards Commission, now requires that candidates in the program choose one area of specialization (i.e., Language Arts, Mathematics, Science, or Social Studies). Previously, students were required to choose two areas of specialization, and thus the different subjects were combined into multiple Areas of Emphasis. This degree is offered at the graduate level and there are numerous courses available to satisfy this content specialization requirement. Therefore, it is no longer necessary to codify the specific areas of emphasis. In the revised program of study, the candidates will take three courses in one of the content areas (English/Language Arts, Mathematics, Science, or Social Studies) based on consultation with their advisor.

1. Why are these area of emphasis being proposed for termination?

These areas of emphasis are no longer necessary to codify in the student's record. The completion of three courses focusing on English/Language Arts, Mathematics, Science, or Social Studies will be clear on the transcript.

2. What will be done to ensure that termination of the areas of emphasis do not weaken the major(s) under which they are offered?

Not applicable. This designation was a coding need when two areas of emphasis were required. This is no longer necessary.

3. How will faculty and staff be notified of the termination? Will termination of the areas of emphasis have any impact on the faculty and staff offering the areas of emphasis?

Not applicable. Students will complete three courses within a specific content area. This is the same level of engagement from faculty partners who teach this content.

4. How will students be notified of the termination? How will students currently in the areas of emphasis be advised to complete the requirements?

All courses will continue to be offered, so students will be able to complete as intended.

5. What plans, if any, are there for subsequent reactivation of the areas of emphasis?

There are no plans to reactivate the areas of emphasis as of now. This change is a result of a state agency change.
