TERRY COLLEGE CO-MAJOR SELECTION CRITERIA REVISION

EFFECTIVE FALL 2011

The Terry College has approved the attached revisions to the Selection Criteria of the International Business Co-Major to be effective Fall 2011.

If approved by the University Curriculum Committee, the Fall 2011 Bulletin Entrance Requirements should reflect the changes to the International Business co-major Selection Criteria. The changes are underlined below.

Entrance Requirements

Completion of Core Areas I-V and Area VI, 60 hours earned, good academic standing (2.0 cumulative UGA G.P.A.), and overall grade point average of 2.6 required to apply. There is no guarantee of acceptance to any major in the Terry College of Business. Applicants are evaluated on the High-Demand - Selection Criteria listed below. This is a high demand major. After meeting the entrance requirements, students will be selected based on the following high-demand selection criteria.

High-Demand Major - Selection Criteria

- Terry ETS Proficiency Profile - Multiple choice examination that measures academic achievement during the first two years of college programs. (____please change name of test)
- Grades in Foreign Language courses - Minimum grade of B required in the two most recently completed non-English language courses.
- Grade in Accounting course - Minimum grade of B required in ACCT 2101.
- Grade in Economics courses - Average grade of B or better in all Economics courses completed to date.
- Statement of Purpose in International Business - A brief essay [300-400 words] in which applicant describes his/her interest in the major and his/her future goals.

Selection Criteria for IB Co-Major

The IB Coordination Committee recently reviewed the criteria that we use to evaluate students who apply for acceptance to the IB co-major (formerly the IB major). The review was prompted by recent changes in the requirements for the co-major, as well as to ensure that applicants are evaluated based on criteria that accurately reflect the skills necessary for success in the IB co-major. The committee particularly feels that applicants' performance in economics courses is relevant to success in other IB-required courses (including ECON 4040). The current criteria and the (revised) proposed criteria are further detailed below.

I. Current International Business Co-Major Selection Criteria:

Effective Fall 2010, student\s wishing to major in International Business must select and complete a comajor program. Students will complete the International Business major in conjunction with a functional major within the Terry College. If students wish to pursue International Business as a co-major with the departmental major of their choice, they will be reviewed on the selection criteria outlined below:

The Terry MAPP is a standardized multiple-choice assessment of academic skills (reading, writing, critical thinking, and mathematics) developed through Areas A-E of the core curriculum. All applicants are required to take this test.

²Final course grades in all non-English language courses. IB majors must start a language sequence before being admitted to a major.

³Final course grades in ACCT 2101 and ACCT 2102. Applicants currently enrolled in ACCT 2102 will be evaluated based on the grade in ACCT 2101.

⁴The Statement of Purpose is a brief essay (300-400 words) in which the applicant describes his/her interest in the major and his/her future goals.

II. Proposed International Business Co-Major Selection Criteria:

Effective Fall 2011, students wishing to co-major in International Business must also select and complete a functional area major in a Terry department. Applicants who wish to pursue the International Business co-major will be reviewed on the selection criteria outlined below:
