Proposal for a New Department College of Education

Department Name: Department of Kinesiology

Current Departments and Programs Affected: It is proposed that the current Department of Exercise Science and the Physical Education Program in the Department of Physical Education and Sport Studies merge.

Academic Rationale for the Merger: The Department of Exercise Science and the Physical Education Program of the Department of Physical Education and Sport Studies are proposing to merge for four major reasons. First, a department combining Exercise Science and Physical Education is a common organizational unit around the country. The combination also is reflected in some professional organizations that include members from both fields, such as the American Academy of Kinesiology and Physical Education, and journals that publish articles from both fields, such as the Research Quarterly for Exercise and Sport. Second, there are many commonalities among the faculty and programs of the two units. The units share a common history. The two programs were combined in the former Department of Physical Education prior to 1991. A recombination of these programs at this time seems to make the most sense for both departments. The programs have related missions and share interests in the health benefits of physical activity and fitness, and in physical performance. Most of the Exercise Science faculty have backgrounds in physical education; some have taught in the public schools; and others have worked in College and University Physical Education Departments. There is also curricular overlap in some of the programs in the two departments. Faculty in Exercise Science teach several of the core content classes in the Health and Physical Education undergraduate major curriculum (biomechanics, exercise physiology, motor behavior) and there is the possibility that this could occur in other areas of the curriculum (measurement and evaluation, courses related to exercise and health/physical fitness). There would be the opportunity for curricular change to make the programs more similar and integrated. Graduate assistants in both departments teach in the Basic Physical Education Program, and faculty in both departments have expertise and interest in this required University instruction program. Third, this merger will directly connect Exercise Science with the primary mission of the College, teacher education. And finally, there is the potential for collaborative research. For instance, an active area of public health research and federal funding concerns relationships among physical activity, fitness and the health of our youth. Several faculty in Exercise Science have done research on this topic, which is also a key interest to several Physical Education faculty. If new faculty were hired with this as a research focus, this would help bridge the research/scholarship divide and promote collaboration. As a second example, Physical Education faculty are engaged in research in motor development, exercise effects, performance training, and the development of elite athletes. This work is taking place in hospitals, pediatric units, international sport organizations, and public schools. These topics and field sites also are of interest to Exercise Science and Physical Education.
