The committee approved a request from the College of Family and Consumer Sciences to terminate the major in Textile Science under the B.S.F.C.S. degree. This request will be forwarded to the Executive Committee of University Council for consideration.

The committee considered the report from the Environmental Literacy Requirement Review Committee. After much discussion, the University Curriculum Committee agreed to ask Dr. Mace to appoint a committee, with representation from across campus, to develop a plan to implement and assess an environmental literacy requirement for the University. The current requirement will remain in place for this academic year. The committee appointed by Dr. Mace will provide the plan to the University Curriculum Committee no later than the last meeting of this academic year, March 26, 2003.
