The University Curriculum Committee met on March 26, 2021, at 3:30 p.m. via the online meeting program Zoom.

Minutes of the January 22, 2021, University Curriculum Committee were approved.

The committee unanimously approved the following proposals, which were forwarded to the Executive Committee of the University Council for consideration<sup>1</sup>:

Proposal to change the name of the Department of Foods and Nutrition to the Department of Nutritional Sciences
Proposal for a new minor in American Sign Language
Proposal for a new minor in Biological and Medical Anthropology
Proposal for a new Graduate Certificate in African Studies
Proposal for a new Graduate Certificate in Transformative Leadership
Proposal to reactivate the Graduate Certificate in Creativity and Innovation
Proposal for a new major in Artificial Intelligence (Ph.D.)

The committee unanimously approved the proposal to terminate the following areas of emphasis under the major in Family and Consumer Sciences Education (B.S.F.C.S.):

- Community Outreach
- Culinary
- Financial Planning
- Early Childhood
- Foods and Nutrition
- Interiors, Fashion, and Textiles

The committee unanimously approved the proposal for two new prefixes, BTSC, Biomedical and Translational Sciences, and NEUR, Neuroscience.

The committee unanimously approved the proposal for a new prefix, SUST, Sustainability.

The committee approved the proposal to establish entrance requirements for the major in Computer Science (B.S.). The vote appears in Appendix A.

The committee unanimously approved the proposal to establish high-demand status for the Area of Emphasis in Product Development and Design under the major in Fashion Merchandising (B.S.F.C.S.).

The committee unanimously approved the proposal to change the prefix FDNS, Foods and Nutrition, to NUTR, Nutritional Sciences.

Following discussion of the proposal for a new Undergraduate Certificate in Data Analytics in Public Policy, a motion was made to change the word "should" to "must" under the Methodology section of the program of study. The motion was seconded, and the motion was approved. After extensive discussion, the proposal was unanimously approved. This proposal was forwarded to the Executive Committee of the University Council for consideration.

Following discussion of the proposal for a new Undergraduate Certificate in LGBTQ Studies, the proposal was unanimously approved with a friendly amendment to revise the language about the elective coursework to read "selected with the approval of the certificate director." This proposal

was forwarded to the Executive Committee of the University Council for consideration.

The committee unanimously approved the proposal to extend the Waiver of the Experiential Learning Requirement due to Impacts Resulting from COVID-19.

The committee discussed a concern from the Biological Sciences Subcommittee that 4000-level courses often do not have prerequisite courses. There is not a policy that requires upper-level courses to have prerequisites and not clear definitions for each course level. The substitute chair asked if the committee members would like to establish an ad hoc committee to consider these issues. The following committee members volunteered to serve on an ad hoc committee: Susan Sanchez, Sheri Worthy, Joe Dahlen, Rodney Mauricio, David Jackson, and Jeffrey Berejikian. The substitute chair will refer this request to John Maerz, Chair of UCC, for consideration.

### **Other Business:**

The University Curriculum Committee approved the following proposal via email on March 5, 2021:

Proposal to extend the exception to the E-suffix approval process for teaching courses online for the duration of the pandemic.

Due to the COVID-19 pandemic and the need to be able to adapt quickly to safety concerns and social distancing requirements, courses may be offered online summer and fall 2021 without obtaining approval for an E-suffix version of the course. Offering courses online, without an E-suffix, will require approval of the department head and dean. This exception to the E-suffix process will be granted on a temporary basis, for the duration of the COVID-19 pandemic only. Following the pandemic, any online courses will be required to be approved through the standard E-suffix approval process.
