Re: Minor in Human Services Leadership proposal

The Department of Counseling and Human Development Services began offering a small number of service courses a number of years ago, in order to meet the needs of undergraduates at the University of Georgia, e.g. academic, career, and life planning, drug and alcohol issues, and interpersonal skills training. The response to these offerings has been very positive with the number of courses increasing to 14 (46 sections) with a total of 2674 credit hours brought into the college during the 2013-2014 academic year. Undergraduate students in psychology, social work, and family and consumer sciences have expressed interest in pursuing a minor in Human Services Leadership in order to complement the training they are receiving in their respective major.

In order to develop a more cohesive undergraduate curriculum in the area of human services, the department began to develop a proposal for an undergraduate major in Human Services Leadership. As part of this process, the faculty is proposing a minor in Human Services Leadership as a stepping-stone to the implementation of a major in Human Services Leadership. Minors traditionally develop from academically established majors. However, Academic Affairs Policy Statement No. 3 MINOR FIELDS OF UNDERGRADUATE STUDY provides for instances in which (1) the proposed minor is in a recognized academic field or discipline, and (2) the University has in place sufficient courses, faculty, and facilities for the offering of the minor.

The Human Services Leadership Undergraduate Minor is designed to prepare students to work with populations from across the lifespan in a variety of non-profit, educational, governmental, and community settings. Guided by social justice and ecological perspectives, students will develop an understanding of environmental and biopsychosocial sources of influence in assisting individuals, families, and groups to respond to developmental challenges and opportunities. The National Organization for Human Services notes that, "The field of Human Services is broadly defined, uniquely approaching the objective of meeting human needs through an interdisciplinary knowledge base, focusing on prevention as well as remediation of problems, and maintaining a commitment to improving the overall quality of life of service

populations. The Human Services profession is one which promotes improved service delivery systems by addressing not only the quality of direct services, but also by seeking to improve accessibility, accountability, and coordination among professionals and agencies in service delivery". We believe our department is uniquely situated to move both the minor and the major forward in the University.

The Human Services Leadership Minor will expose students to the work of a wide variety of human service agencies and will cultivate the skills and perspectives necessary to be effective in those settings. The Human Services Leadership minor will complement such majors as Social Work, Psychology, Sociology, Health Promotion and Behavior, and Human Development and Family Sciences, extending the range of applications of those fields while also preparing students for potential graduate work in those and other areas.
