To whom it may concern,

I am writing in support of changes to our High-Demand Selection Criteria for our Music Education (BMus) and Music Therapy (BMus) majors. We would like to require students to complete one of the following MUSI courses in Area IV as a component of the barrier procedures for entry to these majors:

MUSI 2040 – History of Popular Music MUSI 2050 – Survey Jazz History MUSI 2060 – History & Analysis of Rock MUSI/AFAM/AFST 2080 – African American Music MUSI 2090 – Music & Film MUSI 2300/H – Music in Athens

These requirements stem from curriculum mandates outlined by our national accrediting body, the National Association of Schools of Music, or NASM. NASM requires that all Bachelor of Music degrees must include a non-Western musicology or music and culture course. All of these courses listed above satisfy this requirement. Music Education (B.Mus.)

From: High-Demand Major–Selection Criteria

Entrance audition for first year students that selects students with very high music performance skills in a set instrumentation.

Passing subsequent music performance skills exam in the first and second years that demonstrate increasing musical maturity and skill in at least one performance medium.

At the beginning of the second year of study, Intended Music Education students must apply to the program by submitting either a passing GACE general exam score, or exempting ACT/SAT scores. Students must also have achieved a minimum Overall GPA of 2.8.

Entrance audition for first year students that selects students with very high music performance skills in a set instrumentation.

Passing subsequent music performance skills exam in the first and second years that demonstrate increasing musical maturity and skill in at least one performance medium.

Recommendation of Music Therapy faculty through a formal barrier review procedure during the sophomore year. Criteria for meeting recommendation expectations include: 1. statement of intent; 2. completion of <u>MUSI 2021</u>, <u>MUSI 5400/7400</u>, <u>MUSI 5440/7440</u> with a "C" or higher; 3. meeting with music therapy faculty to discuss admission to the major.
