A motion was made to change the wording for the learning outcomes for General Education Core Curriculum Area IV, Humanities and the Arts, from "describe, interpret, and appreciate" to "describe, interpret, and critique." A vote was called and the motion did not pass. The committee approved the proposal to revise Academic Affairs Policy Statement No. 14, General Education Core Curriculum, to consolidate and reduce the learning outcomes from 39 to 13.

The committee approved the proposal for a new dual degree in M.P.H. with an Area of Emphasis in Health Promotion and Behavior and Ph.D. with a major in Health Promotion and Behavior.
