The committee approved the request to create three new prefixes, AENG, Agricultural Engineering, BIOE, Biological Engineering, and INFO, Informatics.

The committee approved the requests to include the following courses in the Experiential Learning Implementation Plans for the following schools and colleges:

FDNS 4660S/6660S, Food and Nutrition Education Methods, for the College of Family and Consumer Sciences

FANR 4500S, Senior Project in Forestry and Natural Resources Management, for the Warnell School of Forestry and Natural Resources

PATH 4960, Undergraduate Research in Plant Pathology, for the College of Agricultural and Environmental Sciences

The committee discussed the option of delegating authority for approving or denying courses and non-credit activities to fulfill the Experiential Learning Requirement to the Experiential Learning Subcommittee and agreed to continue to leave this authority with the Full University Curriculum Committee.

The committee tabled a proposal to create a new grade, IP (In Progress), until further research could be completed on the possible impact the grade may have on students and policies, as well as for further clarification of the grade definition.

The committee congratulated the current chair, Dr. William Vencill, on his promotion to Associate Vice President for Instruction and voted to elect a new chair via email to begin January 1, 2017.
