The Experiential Learning Subcommittee met on January 30, 2023, at 3:00 p.m. via Zoom.

The subcommittee unanimously approved the minutes of the October 26, 2022, Experiential Learning Subcommittee meeting.

The subcommittee unanimously approved the requests for the following courses to fulfill the Experiential Learning Requirement and be included as options on the Experiential Learning Transcript:

College of Agricultural and Environmental Sciences
ADSC 3190-3190L, Meats Judging II (*Internship*)

Franklin College of Arts and Sciences
WMST 4011, Understanding Research in Women's Studies (*Research*)
WMST 4011W, Understanding Research in Women's Studies (*Research*)

The subcommittee approved FHCE 5305, Housing Management and Policy Practicum (*Creative*), to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript for the College of Family and Consumer Sciences pending revision to the project component of the course, making it mandatory rather than optional. The subcommittee unanimously approved ANTH 4650/6650, Technical Skills in Archaeology (*Research*), to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript for the Franklin College of Arts and Sciences pending revision which clarifies the regularity of meetings and feedback between student and instructor.

The subcommittee unanimously voted to return MATH 4802/6802, Industrial Mathematics (*Research*), to the department for revisions regarding the feedback component, including explanation of how students will receive feedback from industry partners.

The subcommittee unanimously approved the request for the following non-credit activity to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript:

The subcommittee unanimously approved the request for the non-credit activity, McPhaul Center's Child Development Lab Substitute Teacher (*Internship*), to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript for the College of Family and Consumer Sciences, pending revision which clarifies the regularity of feedback received from the supervising teacher. The committee suggested that feedback be incorporated throughout the experience rather than solely in an exit interview.

The subcommittee unanimously approved the requests for the following non-credit activities to be included as options on the Experiential Learning Transcript:
