The subcommittee unanimously approved the minutes of the March 24, 2024, Experiential Learning Subcommittee meeting.

The subcommittee denied ANTH 4620, Applied Anthropology (*Creative*), to satisfy the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript for the Franklin College of Arts and Sciences. The subcommittee recommended that the department submit the course for the Service-Learning attribute to ensure the experiential content of the course is sufficient to satisfy the requirement. If approved for Service Learning, the course will also satisfy the Experiential Learning requirement. A record of voting appears on the last page.
