### New Business:

The Experiential Learning Subcommittee met on August 29, 2023, at 4:00 p.m. via Zoom.

The subcommittee unanimously approved the minutes of the April 10, 2023, Experiential Learning Subcommittee meeting.

The subcommittee unanimously approved the following courses to fulfill the Experiential Learning Requirement and be included as options on the Experiential Learning Transcript:

College of Agriculture and Environmental Sciences

The subcommittee unanimously denied the request from the Office of Instruction for the Apartments for Athens Marketing Internship (*Internship*) pending additional information regarding mentorship. The subcommittee recommended that language be included in the proposal that provides details about the roles of the mentors and students to ensure the student learning outcomes are being met.

The subcommittee unanimously denied the request from the Office of Instruction for the First Responder Health Disparity Awareness Program (*Service*). It was determined that this activity cannot currently be approved to appear on the Experiential Learning transcript due to the lack of activity oversight. The subcommittee would like clarification on the chosen category and details about the work that the students will be responsible for.

The subcommittee unanimously approved the request from the Office of Instruction for the AmeriCorps Community Food Fellows (*Service*) to be included as an option on the Experiential Learning Transcript pending a recommended change to the reflective feedback. The subcommittee also requested additional information regarding what the student will learn from this activity.
