- Through any research course (denoted with an R-suffix)

- Through any CURO undergraduate research course or CURO Research Award
- Through CURO Summer Fellowships

SERVICE:

Students in any major (or intended major) in the College of Veterinary Medicine may fulfill the requirement:

- Through any service-learning course approved by the Office of Service-Learning

Students in any major (or intended major) in the College of Veterinary Medicine may fulfill the requirement by completing any non-course activity that has been approved for experiential learning at the university level.
