The Experiential Learning Subcommittee met on February 9, 2022, at 10:00 a.m. via Zoom.

The subcommittee unanimously approved the minutes of the December 2, 2021, Experiential Learning Subcommittee meeting.

The subcommittee unanimously approved the request for the following courses to fulfill the Experiential Learning Requirement and be included as options on the Experiential Learning Transcript:

The subcommittee also discussed the course, KINS 3450S, Practicum in Fitness and Conditioning, which was approved originally as an internship, but now has been through a course change to become a service-

learning course. It was determined by the subcommittee that the Experiential Learning attribute on the course should be changed from “internship” to “service-learning”.
