The General Education Subcommittee of the University Curriculum Committee met on September 15, 2025, at 10:00 a.m. in 216 Holmes-Hunter.

The subcommittee discussed the implementation of the revised general education curriculum. The discussion included scheduling a full course review of existing core courses in late Fall 2025, as well as the timing of the implementation of the new General Education Core. The full course review will include a two-person team-based approach to reviewing the courses in each area of the core. The teams will review each existing course and approve, deny, or mark the course as "needs discussion." The courses marked as "needs discussion" will be reviewed by the full subcommittee at a meeting in late Fall 2025.

Additionally, the subcommittee discussed the existing Core Area VI courses and options for how those 18 credit hours of major-related core courses will be displayed in the major.

Following the discussion of the revised general Education, the subcommittee unanimously approved the minutes of the March 17, 2025, General Education Subcommittee meeting.
