The General Education Subcommittee of the University Curriculum Committee met on March 17, 2025, at 4:00 p.m. in 315 New College.

The subcommittee unanimously approved the minutes of the October 28, 2024, General Education Subcommittee meeting.

The subcommittee unanimously denied the following course from the College of Environment and Design to be added to list of courses approved to satisfy Area IV, Humanities and the Arts, of the General Education Core Curriculum. The subcommittee unanimously approved the course to be added to list of courses approved to satisfy Area V, Social Sciences, of the General Education Core Curriculum:

HIPR 2000, Introduction to Historic Preservation

The subcommittee considered the following course from the College of Environment and Design to be added to list of courses approved to satisfy Area IV, World Language and Global Culture, of the General Education Core Curriculum. The subcommittee recommended that the department provide additional evidence of the cultural components of the course. The course can be revised to include additional evidence of global culture and be resubmitted for consideration by the General Education Subcommittee. Subsequent to the meeting, the College of Environment and Design sent additional evidence to the subcommittee explaining how this course satisfies the learning objectives for Area IV, World Language and Global Culture. The subcommittee held a vote via email and approved this course.

HIPR 2072, Introduction to Global Heritage Conservation

The subcommittee unanimously denied the following course from the College of Engineering to be added to list of courses approved to satisfy Area IV, World Language and Global Culture, of the General Education Core Curriculum. The subcommittee determined that there is insufficient evidence in the course objectives and topical outline that the course meets the learning outcomes of Area IV, World Languages and Global Culture, of the General Education Core Curriculum

ENGR 2510, Evolution of Engineering: Technology, Society, and Culture

The subcommittee unanimously approved the following courses from the College of Arts and Sciences to be added to list of courses approved to satisfy Area V, Social Sciences, of the General Education Core Curriculum:
