- 7) Copy of the first page of your warranty deed, apartment lease, or other proof of Georgia residency for the past twelve months.

- 9) Copy of your Georgia vehicle registration.
- 10) Copy of voided check showing your Georgia address or other proof of having established a checking/savings account in Georgia.
