The Educational Affairs Committee met on March 22, 2013, at 1:05 p.m.

Minutes of the November 12, 2012, meeting and the February 11, 2013, meeting were approved.

Dr. Rodney Mauricio updated the committee on the results of the Petitions Subcommittee meeting held since the last Educational Affairs Committee meeting. On March 18, 2013, 28 appeals were reviewed, 23 were approved and 5 were denied.

The committee requested that the Academic Advising Coordinating Council ask advisors across campus to remind undergraduate students that the PE requirement is separate from the minimum 120 hours need to graduate.

Dr. Mauricio is scheduled to meet with Janyce Dawkins of the Equal Opportunity Office to discuss the reporting duties of the committee regarding allegations of sexual assault and Title IX of the Educational Amendments of 1972.

The committee approved a proposal from the Registrar to revised the drop/add registration dates to allow the drop period to extend through midnight of the fifth class day (business days) for undergraduate and graduate


students for fall and spring semesters.

The committee briefly discussed a future proposal from the Registrar to revise the 2014-2015 Academic Calendar. The proposal will be reviewed by the Vice President for Instruction and the Provost before being considered by the committee.
