The Educational Affairs Committee met on April 29, 2013, at 3:05 p.m.

Minutes of the March 22, 2013, meeting were approved.

Dr. Rodney Mauricio updated the committee on the results of the Petitions Subcommittee meeting held since the last Educational Affairs Committee meeting. On April 29, 2013, 33 appeals were reviewed, 21 were approved and 12 were denied.

The Petitions Subcommittee will begin reporting any allegations of sexual misconduct included in student appeals to Janyce Dawkins of the Equal Opportunity Office in compliance with Title IX of the Educational Amendments of 1972. Effective this month, a report will be made to Janyce Dawkins when the Petitions Subcommittee receives any appeals which involve an allegation of sexual misconduct on a student while at the university or an assailant who is a student, staff, or faculty member at the university. The appeals information on the Educational Affairs Committee website now includes a statement regarding a student's privacy in matters of Title IX reporting.

Dr. Mauricio updated the committee on the number of hardship withdrawals reviewed by the Office of Student Services in 2012. In 2012, 277 hardship withdrawal requests were reviewed, 234 hardship withdrawals were

approved, 36 partial hardship withdrawals were approved and 7 hardship withdrawals were denied.

The Registrar reported that the revision to the drop/add registration dates to allow the drop period to extend through midnight of the fifth class day has been approved. The Registrar will determine the effective date due to necessary programming in IMS.

The Registrar explained that academic calendars are becoming increasingly difficult for her to develop due to several imposed restrictions by the university and the Board of Regents. The committee received some academic calendar dates used at peer and aspirational institutions. The committee briefly discussed possible revisions and will continue the discussion in the fall semester after reviewing additional data and draft scenarios from the Registrar.

The committee unanimously re-elected Dr. Rodney Mauricio as Chair of the Educational Affairs Committee for the 2013-2014 Academic Year.
